  - Add in any required lines to comply with CAN-SPAM laws (e.g., physical mailing address, unsubscribe link, why customers are receiving the email, etc.).
  - NOTE: Ensure the email is entirely CAN-SPAM compliant and includes a compliant opt-out mechanism.

### Subject line:

### Targeting your audience:

1. Filter your client database to obtain a list of canine-owning clients. For every 200 emails sent out, you can expect approximately 10 clients to respond (5%). In order to get your email list down to a manageable number, here are some filters you can apply:
  - a. Canine-owning clients
  - b. Canine-owning clients with dogs aged 5+ years (increase this age to reduce the number of recipients)
  - c. Canine-owning clients who have visited the clinic in the past 12–18 months
2. Send your email and wait for your clients to come in requesting their free Starter Pack — expect to see approximately 5% of your email recipients come in for this high-value offer.
